Objectives

Investment objective The investment objective of the sub-fund is to provide investors with an adequate exposure to companies involved in private equity activities on a global basis.

Investment policies The Sub-Fund will mainly invest in equities issued by companies incorporated in any OECD country and bonds issued by supranational, government, quasi-government bodies and corporate bonds (min BBB-) issued by companies incorporated in any OECD country under the principle of risk diversification.

The Sub-Fund may also invest in accordance with the terms of the Prospectus, and on an ancillary basis, in other transferable securities, Money Market instruments, derivatives, including but not limited to options, warrants, futures, other equity derivatives traded either on a regulated market or OTC and forward transactions, deposits and units in collective investment schemes.

The Sub-Fund may also hold on ancillary basis liquid assets.

The Sub-Fund may also enter into swap transactions.

The Sub-Fund may invest no more than 10% of its net assets in other UCITS/UCI.

The Sub-Fund will enter into securities lending transactions within the meaning of Regulation (EU) 2015/2365, for a maximum of 70%.



Redemption and Dealing The Sub-Fund is open-ended which means that it may, at any business day on the request of the shareholders, redeem its shares at prices based on the applicable Net Asset Value per Share.

The Net Asset Value ("NAV") of the Sub-Fund will be determined on each Business Day in Luxembourg ("Valuation Day"). The redemption requests will be closed at 4.00 p.m. CET ("cut off time") in Luxembourg on the Business Day preceding the relevant Valuation Day.

Distribution Policy Income arising from the Sub-Fund is being reinvested.

What happens if Mediobanca Management Company SA. is unable to pay out?

Losses are not covered by an investor compensation or guarantee scheme. What are the costs?

How long should I hold it and can I take money out early?
